PRESIDENT'S REPORT

ANNUAL MEETING

1974

IT IS MY PLEASURE TO GIVE YOU A BRIEF LOOK AT THE ACTIVITIES OF THE SASKATCHEWAN SAFETY COUNFIL FOR 1974. IT WILL BE NOTED THAT WE HAVE EXPANDED A NUMBER OF THE PROGRAMS IN WHICH WE HAD PREVIOUSLY BEEN INVOLVED AND IN ADDITION THERE HAVE BEEN SOME NEW PROGRAMS INSTITUTED.

DURING THE YEAR THREE BOARD MEETINGS WERE HELD AND IN ADDITION, EIGHT EXECUTIVE MEETINGS WERE HELD TO DEAL WITH THE DAY TO DAY BUSINESS OF THE COUNCIL. I WISH TO MENTION A FEW OF THE MORE NOTABLE ACTIVITIES THAT HAVE TAKEN PLACE DURING THE YEAR:

A CIRCLE CHECK CAMPAIGN FOR THE SAFETY OF CHILDREN FROM PLAYING AROUND PARKED VEHICLES WAS INSTITUTED AND THIS HAS BEEN WELL RECEIVED. A NUMBER OF THE LARGER COMPANIES NOW ARE REQUIRING THAT ALL DRIVERS OF THEIR VEHICLES MAKE THE CIRCLE CHECK OF THE VEHICLE BEFORE MOVING IT.

SASKATCHEWAN TELECOMMUNICATIONS OFFERED 1,300 OF THEIR EMPLOYEES THE DEFENSIVE DRIVING COURSE.AND JOINS SASKATCHEWAN POWER CORPORATION AND SASKATCHEWAN DEPARTMENT OF HIGHWAYS IN SETTING A VERY FINE EXAMPLE TO WHICH WE CAN REFER IN SELLING THE DEFENSIVE DRIVING COURSE TO OTHER INSTITUTIONS AND COMPANIES.

DURING THE YEAR THE TRAFFIC DIVISION HELD A TRAFFIC SAFETY WORKSHOPS AND THIS WAS CONSIDERED A SUCCESS BOTH IN ATTENDANCE AND IN THE VALUABLE RECOMMENDATIONS THAT CAME FORWARD. THESE HAVE BEEN ADOPTED AS COUNCIL POLICY AND WERE PASSED ON TO THE PROPER AUTHORITIES FOR CONSIDERATION AND POSSIBLE IMPLEMENTATION.

THE OCCUPATION DIVISION HELD ITS FIRST ANNUAL INDUSTRIAL SAFETY SEMINAR AND THIS WAS A TREMENDOUS SUCCESS. IT WAS WELL ATTENDED AND THE QUALITY OF THE KEYNOTE SPEAKERS AND DISCUSSION LEADERS LEFT NOTHING TO BE DESIRED.

OTHER AREAS OF OUR ACTIVITIES HAVE EXPANDED AS WELL. THE DEFENSIVE DRIVING COURSE HAS PICKED UP OVER THE NUMBER FROM PREVIOUS YEARS. A COMMITTEE OF THE HOME DIVISION HAS SPENT CONSIDERABLE TIME IN REVISING THE BABYSITTERS TRAINING COURSE WHICH WILL SOON GO TO PRINT. THIS WILL BE A MARKED IMPROVEMENT OVER THE PREVIOUS COURSE.

DURING THE PAST YEAR THE LEGISLATIVE COMMITTEE ON TRAFFIC AND SAFETY HAS CONTINUED ITS WORK AND WE HAVE BEEN AFFORDED THE PRIVILEGE OF CONSIDERABLE INPUT TO THAT COMMITTEE. WE APPRECIATE HAVING BEEN CONSIDERED IN THIS RESPECT AND WE FEEL THAT THE OPPORTUNITY TO PUT OUR THOUGHTS BEFORE THEM FOR CONSIDERATION WILL HAVE VALUE NOT ONLY TO THE FINAL REPORT, BUT ALSO WILL MAKE THE AUTHORITIES OF THE PROVINCE MORE AWARE OF OUR CONTINUING INTEREST IN ALL FIELDS OF SAFETY.

WE HAVE BEEN ABLE TO CONTINUE OUR CLOSE LIAISON WITH THE SASKATCHEWAN GOVERNMENT INSURANCE OFFICE AND WITH THE HIGHWAY TRAFFIC BOARD, AS WELL AS THE DEPARTMENT OF HIGHWAYS, PUBLIC HEALTH, EDUCATION, AND LABOUR.

AS WAS NOTED IN OUR PREVIOUS ANNUAL REPORT, WE EXPANDED OUR BICYCLE LICENSING PROGRAM AND WHILE IT DID EMBRACE A LARGER NUMBER OF CYCLISTS IN THE PROVINCE, IT DID NOT PROVE TO BE THE FINANCIAL SUCCESS THAT WE HAD HOPED DUE TO A SERIES OF FACTORS.

A NUMBER OF OUR PROGRAMS HAVE EXPANDED AND THIS IN TURN REQUIRES MORE OFFICE SPACE AND MORE STAFF. HOWEVER, THESE EXPANSIONS HAVE HAD TO BE RESTRICTED DUE TO OUR FINANCIAL CIRCUMSTANCES. I WOULD URGE THAT EVERY MEMBER OF THE COUNCIL ENDEAVOUR TO ENLIST OTHER INDIVIDUALS TO BECOME MEMBERS OF THE SAFETY COUNCIL. WE HAVE HAD TO RELY TO A LARGE EXTENT ON THE ASSISTANCE THAT WE HAVE BEEN GRANTED BY THE GOVERNMENT AND BY THE SASKATCHEWAN GOVERNMENT INSURANCE OFFICE. HOWEVER, WE SHOULD NOT HAVE TO RELY SOLELY ON THESE GOVERNMENT DEPARTMENTS AND THEREFORE EACH MEMBER OF THE COUNCIL SHOULD STRIVE TO ENLIST OTHER ORGANIZATIONS, COMPANIES, AND INDIVIDUALS TO SUPPORT THE COUNCIL IN ITS WORK THROUGHOUT THE PROVINCE.

ON BEHALF OF THE COUNCIL MAY I EXPRESS APPRECIATION OF THE SASKATCHEWAN SAFETY COUNCIL TO THE GOVERNMENT OF THE PROVINCE OF SASKATCHEWAN AND TO THE SASKATCHEWAN GOVERNMENT INSURANCE OFFICE FOR ITS FINANCIAL SUPPORT DURING THE PAST YEAR. WITHOUT THIS SUPPORT WE WOULD HAVE BEEN UNABLE TO CARRY ON.

I WILL NOT ENDEAVOUR TO COVER THE FULL ACTIVITIES OF EACH ONE OF OUR DIVISIONS AS THESE WILL BE COVERED IN THE REPORTS OF THE CHAIRMAN OF EACH OF THESE DIVISIONS. MY INTENTION IS TO HIGHLIGHT SOME OF THOSE POINTS WHERE I FEEL THAT WE HAVE MADE THE GREATEST IMPRESSION ON THE ACCIDENT EXPERIENCE IN VARIOUS FIELDS THROUGHOUT THE PROVINCE.

I FEEL I MUST PAY A SINCERE COMPLIMENT TO OUR STAFF WHICH HAS BEEN SHORTHANDED AND STILL HAS BEEN ABLE TO CARRY ON THE PROGRAMS THAT WE HAVE UNDERTAKEN TO DATE. THERE IS NO DOUBT THAT IN THE IMMEDIATE FUTURE WE MUST EXPAND OUR STAFF.

IT IS ALSO ESSENTIAL THAT I MENTION THE VERY FINE SUPPORT THAT WE HAVE RECEIVED FROM ALL AREAS OF THE MEDIA....RADIO, TELEVISION, AND NEWSPAPERS FOR OUR PROGRAMS DURING THE PAST YEAR. WITHOUT THIS SUPPORT WE WOULD HAVE BEEN UNABLE TO CARRY ON. THE TYPE OF SUPPORT THAT WE HAVE RECEIVED WOULD BE FAR BEYOND OUR FINANCIAL ABILITY TO COVER AND THESE HAVE BEEN HANDLED FOR US ON A PUBLIC SERVICE BASIS. WE ARE MOST APPRECIATIVE OF THIS TYPE OF ASSISTANCE.

LAST BUT NOT LEAST, MAY I, AS YOUR RETIRING PRESIDENT, EXPRESS MY APPRECIATION FIRSTLY TO THE STAFF FOR THEIR DILIGENT AND DEDICATED EFFORT AND TO ALL OTHER MEMBERS OF THE COUNCIL WHO SHARED IN THE MANY DUTIES NECESSARY TO KEEP OUR PROGRAMS RUNNING. IN INCLUSIONAL AS YOUR PRESIDENT, I ASSURE YOU THAT YOU WILL CONTINUE TO HAVE MY SUPPORT AND ANY ASSISTANCE THAT I AM ABLE TO OFFER IN THE YEARS TO COME.

EXECUTIVE DIRECTOR'S REPORT AMNUAL MEETING

TWO MAJOR SETBACKS OCCURRED THIS YEAR TO SEVERELY HAMPER OUR EFFECTIVENESS AS A SAFETY COUNCIL. OUR COMPUTER BICYCLE LICENSE PROGRAM GENERATED A LARGE DEFICIT WHICH WILL TAKE A COUPLE OF YEARS OF CAREFUL BUDGETING AND MANAGEMENT TO OVERCOME. PROGRAM CO-ORDINATOR TOM IRELAND RESIGNED FROM THE COUNCIL STAFF TO ACCEPT EMPLOYMENT WITH THE PROVINCIAL E.M.O. AND HIS PRESENCE WILL BE MISSED. HE HAS GIVEN OVER 14 YEARS OF FAITHFUL SERVICE TO THE SASKATCHEWAN SAFETY COUNCIL AND WE WISH HIM EVERY SUCCESS IN HIS NEW ENDEAVORS.

1974 WAS A BUSY AND PRODUCTIVE YEAR FOR OUR COUNCIL WITH MANY OF THE ACTIVITIES RECORDED ELSEWHERE IN THIS REPORT IN THE REPORTS OF THE DIVISIONS.

THE GREATEST CHALLENGE WE FACE IS TO MANAGE OUR LIMITED RESOURCES IN THE MOST EFFECTIVE WAY POSSIBLE IN THE FACE OF INCREASING INFLATION. VOLUNTEER AGENCIES SUCH AS OURS HAVE LITTLE OPPORTUNITY TO COUNTER THESE INFLATIONARY PRESSURES AND WE MUST RELY ALMOST ENTIRELY ON THE GENEROSITY OF THOSE WHO SUPPORT OUR COUNCIL TO REMAIN IN BUSINESS.

WE HAVE ENJOYED ANOTHER YEAR OF EXCELLENT SUPPORT FROM THE GOVERNMENT OFFICIALS WITH WHOM WE WORK, FROM CROWN CORPORATIONS, FROM AN INCREASING SEGMENT OF PRIVATE INDUSTRY, AND MANY SINCERE INDIVIDUALS WHO GIVE GENEROUSLY OF THEIR TIME AND KNOWLEDGE TO THE PROMOTION OF PUBLIC SAFETY. I ALSO WISH TO PAY TRIBUTE TO MY STAFF FOR THEIR ENTHUSIASTIC AND DEVOTED SERVICE. TO THE MEMBERS OF OUR BOARD OF DIRECTORS, OUR EXECUTIVE COMMITTEE AND PARTICULARLY OUR PRESIDENT, MR. McWHIRTER, THANK YOU FOR YOUR INTEREST AND SUPPORT OVER THE PAST YEAR.

AS A RESULT OF THE ANNUAL MEETING ELECTIONS THE EXECUTIVE OFFICERS OF THE TRAFFIC DIVISION WERE:

TWO MEETINGS WERE HELD DURING LAST YEAR'S TERM, ONE IN SASKATOON AND THE SECOND IN MOOSE JAW. THE SUBJECTS DISCUSSED WERE TOO MANY AND VARIED TO OUTLINE IN DETAIL.

HOWEVER, TWO MAIN ITEMS OF THE PROGRAMMES SHOULD BE MENTIONED. THE COMMITTEE HEADED BY MR. W. ANTONIO WHICH WAS ESTABLISHED DURING THE OCTOBER MEETING PRESENTED A REPORT TITLED, "REVIEW OF THE RELATION-SHIP OF MOTOR VEHICLE ACCIDENTS TO SPEED LIMIT REDUCTIONS AS IT APPLIES TO SASKATCHEWAN", AT OUR MOOSE JAW MEETING. THIS EXCELLENT PAPER PRESENTS A COMPOSITE SUMMATION OF PERTINENT INFORMATION REGARDING SPEED AND ITS RELATIONSHIP TO ACCIDENTS. SECONDLY, A COMMITTEE HAS BEEN ESTABLISHED TO STUDY PEDESTRIAN SAFETY AND SCHOOL ZONE REGULATIONS WITH THE INTENT THAT A SET OF REGULATIONS SUITABLE FOR ADOPTION BY THE SASKATCHEWAN SAFETY COUNCIL WILL ULTIMATELY BE PRODUCED.

A HIGHLY SUCCESSFUL TRAFFIC SAFETY WORKSHOP WAS HELD IN SASKATOON IN NOVEMBER, 1974 UNDER THE SPONSORSHIP OF THIS COUNCIL. THE WORKSHOP WAS ORGANIZED AND DIRECTED BY A STEERING COMMITTEE OF THE TRAFFIC DIVISION AND THE EXECUTIVE DIRECTOR. TWENTY-ONE RECOMMENDATIONS CAME

OUT OF THIS WORKSHOP AND FORMED THE BASIS OF A SASKATCHEWAN SAFETY
COUNCIL PRESENTATION TO A COMMITTEE OF THE CABINET OF THE GOVERNMENT

HOME DIVISION ANNUAL REPORT 1974

EDUCATING YOUNG PEOPLE TO BECOME RESPONSIBILE CITIZENS IS A NATURAL CHALLENGE FOR THE HOME DIVISION. A CHILD'S SAFETY BEHAVIOUR IS A REFLECTION OF BOTH HIS PARENTS ATTITUDES AND KNOWLEDGE AND CULTURAL NORMS, BUT DO NOT NECESSARILY ENSURE A HIGH LEVEL OF RESPONSIBLE SAFETY BEHAVIOUR.

WITH THE HIGH DEGREE OF MOBILITY TODAY A GREATER NUMBER OF
YOUNG PEOPLE ARE BEING EMPLOYED IN A SUBSTITUTE MOTHER OR BABYSITTING
CAPACITY, NOT INFREQUENTLY THEIR LEVEL OF COMPETENCE IN THE ACCIDENT
OR EMERGENCY SITUATION IS INFERIOR. SOME RECENT SASKATCHEWAN
ACCIDENTS ATTEST TO THIS FACT. WE CAN TAKE SOME COMFORT IN THE FACT
CHILDREN'S LIVES WERE SAVED BY A CERTIFIED BABYSITTER IN A SASKATOON
FIRE THIS PAST YEAR. A "NORTH-SOUTH" COMMITTEE OF THE HOME DIVISION
AND SPECIAL CONSULTANTS RECENTLY COMPLETED A TOTAL RE-WRITING OF THE
BABYSITTERS COURSE TO MEET THE NEEDS OF OUR CHANGING SOCIETY. THE
COURSE LESSONS INCLUDE ETHICS, CHILD CARE, FIRST AID, FIRE, PLAY,
AND A FINAL EXAMINATION. THE MASSIVE REVISION IS BEING ACTIVELY
PROMOTED AND PUBLICIZED BY OUR OWN MEMBERS AND RELATED AGENCIES.

FIRE SAFETY EDUCATION WAS CHOSEN AS A PRIORITY BY THE MEMBERS
FOR THIS YEAR. IN-SERVICE FIRE EDUCATION WAS PROVIDED FOR THE
DIVISION MEMBERS. A COMMITTEE IS PRESENTLY PREPARING A FIRE SAFETY
FACT SHEET AND SUBSEQUENT DELIVERY SYSTEM.

AN INNOVATIVE RESEARCH PROJECT COMMENCED THIS YEAR. THE
"NEIGHBOURHOOD SURVEY PROJECT" IS DESIGNED TO ENABLE US TO ESTABLISH
THE NEEDS OF HOMEMAKERS FOR SAFETY KNOWLEDGE AND EDUCATION. THE SURVEY

FORMAT TAKES THE FORM OF AN INFORMAL NEIGHBOURHOOD COFFEE PARTY WITH AN UNSTRUCTURED DIALOGUE TO ASSESS AREAS OF SAFETY NEEDS AND CONCERNS. A PILOT PROJECT REVEALED THE FACT THAT FIRE IS THE GREATEST FEAR. THE PARTICIPANTS REQUESTED CHECK LISTS ON WHAT TO LOOK FOR TO PREVENT FIRES AND STEPS TO TAKE IN A FIRE SITUATION. THE RESEARCH PROJECT WILL BE CONTINUED AND EXPANDED TO PROVIDE DIRECTION TO HOME DIVISION ACTIVITIES.

THE DIVISION TO A LESSER DEGREE HAS ADDRESSED ITSELF TO SAFETY AND CARE OF THE ELDERLY, CHILD SAFETY RESTRAINTS, BIKE SAFETY, AND USE OF REFLECTIVE TAPE.

WITH CONSIDERABLY MORE MEMBERS AND THE STRENGTHENING OF LIAISON WITH RELATED AGENCIES, THE HOME DIVISION ANTICIPATES SOME PRODUCTIVE PROGRAMS TO HELP REDUCE THE TRAGEDY OF PREVENTIBLE HOME RELATED ACCIDENTS.

SINCERE APPRECIATION IS EXTENDED TO THE MEMBERS IN THE SPECIAL COMMITTEES WHO HAVE CONTRIBUTED UNTOLD HOURS OF VOLUNTEER TIME.

I URGE OTHER MEMBERS WHO DEVOTED TIME AND EXPERTISE, TO CONTINUE THEIR LOYALTY FOR THE COMING YEAR.

FARM DIVISION ANNUAL REPORT 1974

ALTHOUGH THERE HAVE BEEN MANY NOTABLE ACHIEVEMENTS IN FARM SAFETY SUCH AS NOISE LEVEL PROTECTION, DUST PROTECTION, ROLL-BARS AND SHIELDS, MANY POTENTIAL HAZARDS REMAIN. WE RECOGNIZE A NEED FOR RESEARCH, PROMOTION AND ENFORCEMENT IN MANY AREAS.

ITINERANT FARM SAFETY OFFICER

THE FARM DIVISION RECOGNIZES A NEED FOR A MORE ACTIVE SAFETY PROGRAM DIRECTED AT RURAL PEOPLE. WE ARE PROPOSING THE HIRING OF A SAFETY OFFICER WHO WOULD BE AN EMPLOYEE OF THE SASKATCHEWAN SAFETY COUNCIL, WOULD CALL AT FARMS, SPEAK AT MEETINGS AND PROMOTE SAFETY EQUIPMENT IN A DESIGNATED AREA OF THE PROVINCE. WHEN INVITED, THE OFFICER WOULD EVALUATE HAZARDS ON FARMS AND RECOMMEND SOLUTIONS. STATISTICS WOULD BE GATHERED AS A SECONDARY BENEFIT.

THE PROJECT IS PROPOSED AS AN EXPERIMENT. IT MAY BE FINANCED BY SEVERAL CO-OPERATIVE ORGANIZATIONS. NO EXPENSE IS TO BE INCURRED BY THE SASKATCHEWAN SAFETY COUNCIL.

FARM ACCIDENT STATISTICS

COLLEGE AND SCHOOL DIVISION ANNUAL REPORT 1974

DURING 1974 THE MAIN PROJECT OF THE DIVISION WAS PROMOTION OF THE SAFE BICYCLING COURSE OFFERED BY THE COUNCIL. OVER 2,000 YOUNG BICYCLISTS RECEIVED INSTRUCTION IN PROGRAMS ON BICYCLE SAFETY DURING 1974 -- 748 IN PEDAL PUSHERS AND 1,296 RECEIVED THE CANADA SAFETY COUNCIL BICYCLE SAFETY COURSE. THE COUNCIL CO-OPERATED WITH THE RED CROSS YOUTH DIVISION IN PROMOTION OF THEIR "BIKE FOR YOUR LIFE PROGRAM" AND THE OPTIMIST CLUBS OF SASKATCHEWAN ASSISTED THE COUNCIL IN PROMOTION OF BICYCLE SAFETY WEEK IN APRIL OF 1974.

THE SCHOOL SAFETY POSTER PROGRAM WAS REASONABLY WELL RECEIVED IN 1974 IN SCHOOLS IN SASKATCHEWAN, HOWEVER, MORE PROMOTION WOULD RESULT IN MORE TEACHERS AND SCHOOLS ACCEPTING THIS PROGRAM. IT IS AN EXCELLENT VEHICLE FOR PROMOTING SAFETY IN THE CLASSROOM AT A VERY NOMINAL COST.

THE SCHOOL BUS DRIVER SAFETY SLIDE SCRIPT PROGRAM ACHIEVED

A VERY GOOD CIRCULATION DURING 1974 AND IT IS ANTICIPATED THIS

TRAINING PROGRAM WILL HAVE EXTENSIVE USE IN YEARS TO COME WITH
